4.0 REVIEW OF MEMO FROM CLERK-TREASURER

Clerk-Treasurer Linda Ringler read aloud her memo, dated January 31st, 2013, pertaining to Draft Budget No. 2 for the year 2013. The Committee reviewed the following information:

- ➤ Local Municipal Tax Rate Survey 2012
- ➤ Summary of 2013 Assessment increase
- ➤ Estimated/real Board Levies
- Capital Projects
- ➤ Payroll Costs @ 2013 rates
- ➤ Long Term Loan Payments and Interest Schedule
- Estimated summary of reserves as of November, 2012

During the above-noted review, the following comments were made, and instructions were given:

- ➤ Contact insurance co. to advise them of new playground;
- ➤ Source water protection contact other municipalities to partner with them on education as a result of Source Water Protection Plan;
- ➤ Cost estimate from Knight Piésold in the amount of \$36,000, which allowed \$4,000 to be redirected towards upgrades to the building at the landfill site;
- ➤ Contact Planner to ascertain if there is any way to have commercial/industrial properties assessed as such;
- Reminder letter to owner re: expiry of three-year period for internal dwelling unit in furniture making business;
- ➤ Public Works Supervisor Real Gauthier provided a cost estimate of \$15,000 from Lewis Motors for rigid frame suspension for the International Truck. Council requested that the insurance company be contacted with respect to this matter as a result of the failure of Lewis Motors to deliver the truck according to township specs.;
- ➤ Roof insulation work at garage needs to include work on steel beams;
- ➢ 'Contribution from Reserves for Gas Tax' in the amount of \$52,000 to be transferred from bridge repair work to the MIII grant application for the Chiswick Line project, and increase of \$86,500 to the budget allocation to cover the township's contribution in the event that the application is approved. Revisions to the budget will be made to reflect revenues and expenditures accordingly. The Committee will be looking to find the funds for the bridge repair work elsewhere so that these projects can be carried out in 2013.
