"Complaints" Policy

The Committee reviewed the existing "Complaints" policy, and after some discussion, put forward a recommendation to have a summary report of complaints prepared monthly for the Council agenda. The report would contain the number of complaints, the nature thereof, and how the complaints were resolved. Complaints addressed to the Public Works Dept. would be required to be returned to the municipal office with a note as to the action taken. This report would be provided to Council as a "Confidential Staff Memo".

Resolution 2013-03 (GGC)

Teresa Miller - Cec Reid: Be it resolved that the General Government Committee recommends to Council that the following revisions be made to Bylaw 2010-06:

- Definition of "Herding Dog" to be added.
- Amend so that Livestock Guardian Dogs do not have to wear collars can be identified with microchips or tattoos.
- Licence fee for Livestock Guardian Dogs and Herding Dogs \$10 each.
- Section 3(s) amended to read that the by-law applies to all dogs residing at all residences in the Township of Chisholm, except where noted.

During the above-noted discussion, the Committee requested that the records for grandfathered dog owners (more than three dogs per household as of 2001) be updated to reflect the current status.

Resolution 2013-04 (GGC)
