### **OPEN FORUM**

The Contractor informs the Committee that people are starting to use clear bags but still including recyclable material in them. There still needs to be a lot of educating.

Cindy Scarfone mentions that it might be a good idea for someone from the Committee to contact the Township of South Frontenac regarding their clear bag policy.

#### **Resolution 2013-11 (LEC)**

Lori Anderson – Janice Reid: Be it resolved that the Landfill Education Committee recommends to Council that an information flyer be mailed out to all residents in mid April indicating all the materials that are recyclable and materials that are not. **‘Carried’**

## **NEW BUSINESS**

Two items added to this section: Signs and Role Playing

- a) “Did You Know” column for April Newsletter: - New list of recyclable materials according to R & D Recycling.
- b) Signs – Susan has sourced out a few printing companies regarding signs to be posted at various locations in the Township. She brought a few samples for the Committee members to look at. Everyone agreed on two of them but both needed a few changes. Susan to bring this back to the companies.
- c) Role Playing – Through some role playing, Susan impersonated a resident attending the Landfill site with Heather going through the garbage bags and sorting out the contents. There is consensus that to expect 100% compliancy is not realistic and that residents should be given a warning the first time. Once again there is concern expressed regarding the resorts and the Golf Course being fully compliant at the onset.

It was suggested that perhaps a form letter could be sent out to the non-compliant residents, giving them a friendly reminder.
