### **NEW BUSINESS**

- a) A letter was received from the Management of Wassi Lodge outlining their plan to implement the clear bag policy.
- b) Discussion followed on the topic of garbage at the Public Beach and the parks in the Township. This matter will be followed up at the next Public Works Committee meeting by Chairperson, Susan Major.
- c) Two samples of signs to be posted in the Township were circulated. Some changes and corrections need to be made before bringing to Council for final approval. Staff is to contact the company to make these changes.

- d) Wassi Lodge and Booth Landing have already sent in their request for signs/posters for their businesses.

The contractor has drafted a letter that he will be distributing to his customers as well as a notice that he will attach to the garbage bags informing them as to why he did not pick up their garbage.

## **GENERAL DISCUSSION**

Discussion centered around the rate of compliance expected on May 1<sup>st</sup>. The consensus was that there still needs to be a lot education in order to achieve 100% compliancy.

Staff is to include a notice in the next newsletter informing residents about By-law 2008-21 that clearly states that recyclable materials are unacceptable at the landfill site. Staff is also to include a final notice in the upcoming newsletter as to the implementation of the clear bag policy.

Landfill attendant is asking for clear written directions from Council as to how to proceed with implementation of this policy. Chairperson Susan Major will be addressing Council regarding this matter at their next meeting.
