TOWNSHIP OF CHISHOLM INAUGURAL MEETING OF 2015 – 2018 COUNCIL TUESDAY, DECEMBER 9TH, 2014

The inaugural meeting of Chisholm Township Council, for the 2015 – 2018 term of office, was called to order by Clerk-Treasurer Linda Ringler, who welcomed the guests in attendance: David Durocher, Tim Grimster, Les Milton, and Ashley Muttart.

The 'Declaration of Office' was taken by Mayor Leo Jobin, and Councillors David Hodgins, Chris Jull, Walter Ross and Annunziato (Nunzio) Scarfone.

Mayor Leo Jobin, in his inaugural address, noted the importance of maintaining respect for each other during Council deliberations, and working together for the community as a whole. Mayor Jobin expressed the belief that the Township has a good Council, who will work well together.

Councillor David Hodgins, in his inaugural address, noted that he is looking forward to his second term on Council, and was of the opinion that with the stubbornness of the Council, it should be able to move mountains. Councillor Hodgins commented that, in his opinion, Chisholm Township is the best place to live, work and play.

Councillor Chris Jull, in his inaugural address, commented that he is in agreement with Councillor Hodgins. He also noted that he has come to respect the members of Council in the short period of time that he's known them. Councillor Jull noted that he will try to get behind them as much as possible.

Councillor Walter Ross, in his inaugural address, noted that the Township had some big events this year, i.e. Village Road. Councillor Ross expressed the hope that taxes can be kept down, and was of the opinion that balance is what is required, and is confident that it can be done with the new Council.

Councillor Nunzio Scarfone, in his inaugural address, commented that he had been attending meetings for a few years, and expressed the opinion that as a group, Council can do a good job. Councillor Scarfone was of the opinion that all the members need to speak their minds, and communicate what they have in their heads, and was confident that this Council could do that.

Tim Grimster and Les Milton extended congratulations to the new Council. Ashley Muttart expressed the opinion that the Council members will do a good job, and told them not to be afraid to call on him if they need assistance in research or anything.

A short recess was taken to allow those in attendance an opportunity to congratulate the new Council.
