#### Resolution 2016-12

Chris Jull – Nunzio Scarfone: **WHEREAS** in April 2012, the Ontario Minister of Energy established the Ontario Distribution Sector Review Panel to provide expert advice to the government on how to improve efficiencies in the sector with the aim of reducing the financial cost of electricity distribution for electricity consumers; and

WHEREAS in the report, Renewing Ontario Electricity Distribution Sector: Putting the Consumer First, the Panel has produced a thorough review of the sector and has put forward a plan for building a new model for electricity distribution in Ontario, one that creates robust, efficient and well-resourced utilities that will reduce costs to the consumer and support the continued economic growth of this province; and

WHEREAS the Report points out that Ontario currently has the most fragmented distribution sector in Canada, and calls for a major restructuring of Ontario's electricity distribution sector which would consolidate the Local Distribution Companies in Ontario into eight to twelve larger regional distributors; and provide cost savings and a more efficient electricity distribution system; and

**WHEREAS** in this highly competitive world it is vital that electricity be delivered in the most efficient and cost effective manner to ensure that the electricity distribution sector thrives and meets the challenges of the coming decade,

**NOW THEREFORE BE IT RESOLVED** that the Council of the Corporation of the Township of Chisholm petitions the provincial government to immediately halt the privatization of Hydro One, and seriously consider the recommendations outlined in the Report, with a view to providing a more cost efficient electricity distribution system for all Ontarians, and

**THAT** a copy of this resolution be forwarded to all municipalities in the Districts of Nipissing and Parry Sound for consideration and support; and

**THAT** a copy of this resolution be forwarded to the Honourable Kathleen Wynne, Premier of Ontario, the Honourable Charles Sousa, Minister of Finance, the Honourable Bob Chiarelli, Minister of Energy, AMO, and FONOM. **'Carried'** 

#### Resolution 2016-13
