

**THE CORPORATION OF THE TOWNSHIP OF CHISHOLM**

**BY-LAW NO. 2009-35**

*Being a By-law to amend By-law 2008-21 for establishing and maintaining a system for the disposal of solid waste in the defined areas of the Township of Chisholm.*

**WHEREAS** on July 8<sup>th</sup>, 2008, pursuant to the provisions of Section 10(2) of the Municipal Act, S.O. 2001, c.25, the Council of the Corporation of the Township of Chisholm enacted By-law 2008-21 for establishing and maintaining a system for the disposal of solid waste in the defined areas of the Township of Chisholm.

**AND WHEREAS** it is deemed expedient to amend certain provisions thereof.

**NOW THEREFORE** the Council of the Corporation of the Township of Chisholm hereby enacts as follows:

1. Section 1 – Definitions – is amended by adding the following definition for Landfill Pass Card:

*“Landfill Pass Card” means a card provided to each resident or property owner to entitle same to deposit household garbage at Waste Disposal Site.*

2. Section 2 is amended by adding the following new section after Section 2 (2) in the by-law:

*No person shall dispose of shingles at the Waste Disposal Site without providing a copy of Building Permit issued to resident depositing shingles, unless permit was not required due to the nature of the work (i.e. –dismantling building less than 106 sq feet or a small repair to an existing building) in which case the resident shall obtain a letter from the Building Official indicating that a building permit was not required.*

3. Section 2(4) is deleted in its entirety and replaced with the following:

*No person other than a resident, property owner or agent of same with proper landfill pass card may deposit waste at the respective Waste Disposal Site.*

4. Section 2(5) is deleted in its entirety and replaced with the following:

*Household garbage will only be accepted when bagged and adequately fastened so as to prevent spillage.*

5. Section 2(10) is deleted in its entirety and replaced with the following:

*Any person depositing solid waste at the Waste Disposal Site, other than bagged household waste, except the Chisholm Township’s employees or agents while in the course of their duties as such, and private waste collectors hauling bagged household waste, shall pay the tipping fee set forth in Schedule “A” attached to and forming part of this By-law.*

6. A new section entitled “Bag Limit System” is to be added after Section 2:

*(1) Effective December 1, 2009, the Township shall have in force a bag limit system, limiting the number of bags of garbage to be deposited at the Waste Disposal Site per year to the following:*

- a. Household resident or owner – 104 bags per year;*
- b. Commercial or industrial property owner, described as persons that pay commercial or industrial taxes or deemed to be a business by the Township – 260 bags per year;*
- c. Vacant land owners – 16 bags per year.*

*(2) New landfill pass cards will be issued annually to township residents.*

*(3) Private garbage contractors are responsible for looking after their customers’ landfill pass cards.*

*(4) The township shall allow residents to deposit one half-ton truck load or trailer load of waste, free of charge once a year at the Waste Disposal Site. This free load of waste does not include bagged household garbage above the bag limit.*

7. Notwithstanding Section 6(1) residents, commercial and industrial property owners, and vacant land owners may deposit more bags of garbage than the maximum limit per year. However, these additional bags would be subject to tipping fees outlined in Schedule "A" attached to and forming part of this by-law.
8. Material brought to the Waste Disposal Site in half-ton trucks, trailers, and trucks and containers will not be accepted unless it is sorted and can be dumped in respective areas.
9. Companies delivering material to the Waste Disposal Site in containers must provide the name and address of property owner from where waste material originated.
10. Schedule "A" is deleted in its entirety and replaced with a new Schedule "A", attached hereto and forming part of this by-law.
11. Schedule "C" is amended by adding the following item No. 7 after Item No. 6, which reads as follows:

*Televisions, and electronic equipment.*

**SCHEDULE "A"**

The following tipping fees will apply at the Waste Disposal Site located on Lot 23, Concession 6, 201 Fossmill Road, being Parcel 13159 Nip. in the Township of Chisholm.

**TIPPING FEES FOR SORTED MATERIAL**

Half-ton truck or trailer <i>(unbagged materials and shingles)</i>	\$20.00 per load
Single Axle Dump Truck	\$100.00 per load
Tandem	\$125.00 per load
Triaxle Truck	\$150.00 per load
Semi Dump Truck	\$150.00 per load
Slide-off Container – 20 cubic metre	\$160.00 per load
- 30 cubic metre	\$240.00 per load
- 40 cubic metre	\$320.00 per load
- over 40 cubic meters	\$320.00 plus \$8.00 per cubic metre for ever cubic metre or part thereof over 40 cubic metres.
Large Appliances – <i>including air Conditioners, dehumidifier, refrigerator, freezers – Tagged free of CFC's</i> (Doors must be removed from refrigerators and freezers)	NO CHARGE
Tires	NO CHARGE as per Ontario Tire Stewardship Standards
Furniture – Per Unit	\$5.00
Mattress/Box spring	\$5.00 each
Over limit garbage bags – Per Bag (Residents)	\$1.00
Over limit garbage bags – Per Bag (Commercial/Industrial property owner or those deemed to be a business by the Township)	\$3.00
Fee for opening Waste Disposal Site outside regular hours	\$100.00 (at Township's Convenience)

**BAGGED HOUSEHOLD WASTE IS EXEMPT FROM THESE FEES UP TO AND INCLUDING ANNUAL LIMIT ON PASS CARD.**

**MATERIAL NOT SORTED WILL NOT BE ACCEPTED.**
