## TOWNSHIP OF CHISHOLM OFFICIAL PLAN REVIEW

J.L. Richards & Associates Limited have been retained to help the Township with its Official Plan review. J.L. Richards have proposed a four-phase approach that will introduce the project to the community, review existing background studies and reports, draft an update to the existing Official Plan, consult with the public and provincial interests to gather input and finally draft an Official Plan that will be submitted to the MMAH (Min. of Municipal Affairs & Housing) for their review and approval.

This is a great opportunity for all community members to weigh in on their vision for the future development of lands in the Township by participating in public presentations and submitting your comments to the project team. Initial input from the MMAH, OMAFRA, MECP, MNRF, Ministry of Mines, MCM, MTO and local Indigenous communities is being gathered to shape the draft plan. An introductory presentation will be made to Council on October 8<sup>th</sup>, 2024 – come and learn about the Planning Process in your community!

### FIRE PREVENTION WEEK OCTOBER 6-12, 2024

**This Fire Prevention Week, make Smoke Alarms work for you.**

Working smoke alarms are the number one way to protect your family from fire. According to the National Fire Protection Association, smoke alarms reduce the risk of death in a home fire by more than half. Of fire deaths that do occur in homes, roughly three out of five occur in homes that either lack smoke alarms, or have alarms that are not working.

“Working smoke alarms make a life-saving difference in a home fire, by giving people the time to get out safely,” says Chisholm Fire Chief Ray Ford. “This year’s Fire Prevention Week campaign helps remind everyone about the importance of checking and maintaining your smoke alarms.”

The Fire Department offers these key smoke alarm safety tips and guidelines:

- Install smoke alarms on every level of the home, and near sleeping areas so they can be clearly heard.
- Test smoke alarms at least once a month by pushing the test button.
- Replace smoke alarms when they are 10 years old. (The manufacture date is typically on the back.)
