This Notice is forwarded to you in accordance with section 45, Subsection 5 of the Planning Act, R.S.O., 1990, as amended.

An application has been received from Michael Salo, requesting permission to increase the maximum lot coverage for accessory buildings from 5% to 6%, to build an additional accessory building. PUBLIC HEARING: The Committee of Adjustment wishes to advise you, as a property owner located within 60 meters of the Applicant's land, of the Hearing. The Committee shall hear the Applicant and every other person who desires to be heard in favour of, or against, the application.

INFORMATION REGARDING THE APPLICATION: Information regarding the application is available for review in the Municipal Office during regular office hours (9:00 a.m. - 4:30 p.m.).

FAILURE TO ATTEND HEARING: If you do not attend the hearing, it may proceed in your absence and except as otherwise provided in the Planning Act, you will not be entitled to any further notice in this proceeding.

If you wish to be notified of the decision of the Township of Chisholm Committee of Adjustment in respect of this application, you must submit a written request to the Committee of Adjustment. This will also entitle you to be advised of a possible Ontario Land Tribunal. Even if you are the successful party, you should request a copy of the decision since the Township of Chisholm Committee of Adjustment decision may be appealed to the Ontario Land Tribunal by the applicant or another member of the Public.

To appeal the decision to the Ontario Land Tribunal, send a letter to the Secretary of the Township of Chisholm Committee of Adjustment outlining the reasons for the appeal. You must enclose the appeal fee of \$400.00 for each application appealed, paid by cheque, made payable to the Ontario Minister of Finance.

THE APPLICANT SHOULD BE PRESENT AT THE HEARING TO PRESENT THE APPLICATION, IF NOT PRESENT APPLICATION MAY BE DEFERRED.
