(a) Memo from CAO Jenny Leblond, Re: 2023 Budget Change (Encl.)

Resolution 2023-156 Bernadette Kerr and Nunzio Scarfone: Be it resolved that the Council of the Corporation of the Township of Chisholm change the capital budget expense for the dump truck/plow from \$387,000 to \$397,014 to account for the HST expense that is not refundable to the township and further increase the amount of borrowing by \$10,014. (b) Memo from Recreation Committee Re: Bottle drive shed (Encl.)

(h) Request for a letter of support for the Powassan Family Health Team expansion (Encl.) **Resolution 2023-163** Claire Riley and Bernadette Kerr: Whereas the Powassan and Area Family Health Team (PAAFHT) was officially launched in August 2011.

Whereas the boundaries of PAAFHT stretch from Loring and Restoule in the west to Chisholm Township in the east, and from East Ferris in the north to Trout Creek and Laurier in the south. Whereas the PAAFHT has an opportunity to submit an application for Expression of Interest to expand and enhance interprofessional primary care teams.

Whereas the application is focused on expanding the provision of comprehensive primary health care to areas that have not had these services and have populations that are both marginalized and vulnerable.

And further will also expand services in the area to include physiotherapy and a nurse practitioner to provide acute/episodic services and referrals to other FHT programs and services to unattached patients.

And further this expansion would increase the ability to provide the right care in the right place at the right time.

Whereas the PAAFHT is planning to provide expanded services in Bonfield and South River/Machar and add new staff members including a nurse practitioner, registered practical nurse, social worker and physiotherapist as well as supporting administrative staff.

Whereas addressing the need for access to an interdisciplinary team will significantly enhance health outcomes and reduce emergency room visits and overall healthcare costs.

Now Therefore be it resolved that the Council of the Corporation of the Township of Chisholm is pleased to support the Powassan & Area Family Health Team Primary Care Expansion Expression of Interest application for expanding and enhancing interprofessional primary care teams

And further that this resolution be forwarded to Ontario Health, MPP Vic Fedeli and MPP Sylvia Jones. 'Carried'
