# SUBJECT: FONOM Conference 2024

I was pleased to attend the FONOM conference held in Sudbury from May 6th-8th. The theme and content of the conference, « Unlocking the North's Potential », offered exciting prospects for the northeastern region of the province, including:

- a heightened focus on mining exploration and development to meet the increasing demand for critical mineral extraction to support electric vehicle manufacturing; there are currently 9 mines that are "ready-to-go" once global investments are secured;
- the need to procure additional capacity to meet projected energy requirements and the prospects of new hydro generation installations in northern Ontario in the next few decades;
- the reinstatement of the Northlander passenger rail transport from Toronto to Timmins (with service to Cochrane) using a modern transportation system (no date yet provided);
- a growing engagement with indigenous communities (consultation, communication, collaboration) whose lands are impacted by proposed developments.

Municipal concerns included:

- the impact of proposed developments on northern roads and highways;

- the lack of funding to address actual and anticipated capital costs;

- the limited local benefits of proposed mining developments because critical minerals will likely leave the north once extracted;

- the importance of finishing the widening of Highway 69 (approx. 68 km) and continuing to widen Highways 11 and 17 using the 2 +1 lane model;

- the devastating impacts of the decline in the forestry industry and recent mill closures.

Conference Report by Bernadette Kerr, May 23, 2024 FONOM 2024: Unlocking the North's Potential

Highlights and Impressions

Although many of the sessions' primary content was focused on forestry and mining there was still content applicable to Chisholm Township looking beyond what was done to see 'how' they were achieved.

Of the many Ministers and their representatives who presented, the Honourable Stan Cho, minister of Long Term Care made the most favourable impression. He seems very aware of the current status of his portfolio, from what is to what needs to be done. With his knowledge and passion we only need hope he can carry though with enough funding to get things done and to make a difference in a timely manner.

There was an update by Nuclear Waste Management on the ongoing struggle to make a decision on the location of future storage of used nuclear fuel. They are still, however, facing a large amount of pushback from the two locations concerned. On a positive note, there is also research being conducted to reclaim the remaining amounts of energy in the fuel that will then potentially change the face of the entire project. See link below.

Several sessions focused on Mining and Forestry. The advantages and disadvantages of having interdependent industries ie initial wood products and by-products and the chaos created when one or the other is forced to close highlighted the ongoing problems of industry in the north. It's an ongoing problem, with no immediate solution.

From the office of the Minister of Energy and Natural Resources came the acknowledgement of the importance of keeping the money in the north. Beyond jobs and other incomes from the initial endeavours, processing and end product manufacturing also needs to remain in the north. This waits to be seen.

Of larges impact to me is The City of Sudbury's approach to addressing homelessness, entitled Coordinated Access System. As the name suggests, they have, through collaboration of all the currently established agencies, been able to bridge the problem areas of connection and communication between resources and the people in need. They have established an identification and registration process that while maintaining privacy, identifies and monitors people to help them through their changing needs and navigate through the system toward a more permanent self sufficient lifestyle. They are participating in a pilot project that is being watch closely because of their strong success rate.

Our hope would be that North Bay (where any homeless people from Chisholm would migrate) would be able to establish or adopt a similar program.

In conclusion I would like to say that although on the surface this conference didn't offer a huge amount of material that can be immediately applied to the daily workings of Chisholm Township, there was much to offer on how to achieve more with less. The predominant underlying themed was "Collaboration". The word was used in many different contexts and situations, but it emphasized that none of us are alone, and that with consious effort and through working with others we can have a bright future.







The North Bay-Mattawa Source Protection Committee has prepared draft updates to the Source Protection Plan and is conducting a public consultation period. As part of the updates, mapping has been revised for the Callander municipal drinking water system and its Intake Protection Zone. The property with roll number 48310000021381000000 in the CHISHOLM TOWNSHIP would lie within the revised mapping.

You are invited to review the proposed mapping and updated Source Protection Plan. Please see the attached Public Consultation Notice for details on how to get more information, attend an information session and provide comments to the Source Protection Committee.

Blue green algae (cyanobacteria) has been identified as a water quality issue for the Callander municipal drinking water system. Phosphorus contributes to the occurrence of cyanobacteria blooms. Callander Bay and all upstream watercourses, such as the Wasi River, are included in the mapping. Examples of activities that can contribute phosphorus include commercial fertilizers, agriculture and sewage systems, if these activities are within 120 metres of a watercourse, waterbody or wetland.

The Ontario Building Code (OBC) requires mandatory maintenance inspections to be conducted every five years on sewage systems which fall within specific areas identified in the Source Protection Plan as governed by the Ontario Clean Water Act.

Your property falls within the Mandatory Maintenance Inspection Program area. The objectives of the mandatory maintenance inspection program are to determine if the existing septic system, at the time of inspection, is showing any obvious or outward signs of malfunction or failure and determine the location of the sewage system components in relation to wells, watercourses and property lines where possible. The mandatory maintenance inspection is a visual inspection. They are designed to be non-intrusive and will generally avoid significant disturbance to the system and surrounding soil area.

- Applied the 2021 Technical Rules and Tables of Drinking Water Quality Threats including an updated list of applicable threat subcategories and vulnerable areas in several policies where needed.
- Separated out the education policy HAZ1 for dense non-aqueous phase liquids (DNAPLs) from a proposed policy HAZ2 for organic solvents due to different applicable vulnerable areas for DNAPLs and organic solvents.
- Added storage of snow as an applicable threat category in policy ICA1.
- Changed SAL1 policy approach (to manage road salt storage) from land use prohibition to education policy (small quantities of exposed road salt storage have been identified as a threat. Since no permits are needed, an education program is a suitable method to address an activity that can occur in many locations).




Figure 2a: Proposed Impervious Surface Area in Powassan Wellhead Protection Area (WHPA)




Figure 2b: Current Impervious Surface Area in Powassan Wellhead Protection Area (WHPA)




Figure 3a: Proposed Impervious Surface Area in Mattawa Wellhead Protection Area (WHPA)







Figure 3b: Current Impervious Surface Area in Mattawa Wellhead Protection Area (WHPA)



# Figure 4a: Proposed Impervious Surface Area in South River Intake Protection Zone (IPZ)








Figure 5a: Proposed Impervious Surface Area in North Bay Intake Protection Zone (IPZ)




Figure 5b: Current Impervious Surface Area in North Bay Intake Protection Zone (IPZ)




Figure 6a: Proposed Impervious Surface Area in Callander Intake Protection Zone (IPZ)




Figure 6b: Current Impervious Surface Area in Callander Intake Protection Zone (IPZ)




Figure 7a: Proposed Impervious Surface Area in Highly Vulnerable Aquifers (HVAs)




Figure 7b: Current Impervious Surface Area in Highly Vulnerable Aquifers (HVAs)

Dear Heads of Council and First Nation Chiefs:

I am pleased to share that the *Community Safety and Policing Act, 2019* (CSPA) came into force on April 1, 2024, and would like to take this opportunity to extend my gratitude to you and your communities. You have been instrumental in shaping the compositions for the newly established Ontario Provincial Police (OPP) detachment board framework.

The detachment board framework, as laid out in the CSPA and the new OPP Detachment Board Regulation, introduces a modernized approach to OPP policing by providing avenues for greater civilian governance. It ensures that each municipality and First Nation community receiving policing services from the OPP has an opportunity to represent their local perspectives, needs, and priorities.

The regulation with details of the board compositions and other board matters is available here: <u>O. Reg. 135/24: OPP DETACHMENT BOARDS (ontario.ca).</u>

With the OPP detachment board framework now in effect, I would like to remind you of some key operational requirements.

# **Detachment Board Catchments**

The maps that are referred in the regulation are attached for your reference. These maps have been developed to show the catchments for situations in which there are multiple boards for the same detachment. Should you have any questions related to the maps or OPP detachment board regulation, please contact Rachel Ryerson, Manager of the Public Safety Policing Policy Unit, at <u>Rachel.Ryerson@ontario.ca</u>.

### **Training and Appointments**

With the new framework there are three types of appointments to the new OPP detachment boards as set out in the regulation: members who are members of a council of a municipality or band council of the First Nation; members representing the community who are neither a member of the council or band council of, nor an employee of the municipality or the First Nation; and provincial appointees. The appointment of council and community representatives are to be conducted locally, with the communities and First Nations assuming responsibility for the process for making appointments identified in the regulation.

Agency Profiles have been created on Ontario's Public Appointment Management System (PAMS), that will be used to facilitate the appointment of provincial appointees to OPP Detachment Boards (<u>OPP Detachment Board – Public Appointments</u> Secretariat (gov.on.ca)).

All board members are required to have completed mandatory roles and responsibilities training before exercising their responsibilities as detachment board members. Information regarding the roles and responsibilities training and provincial appointments have been shared with detachment leads who are the key contacts identified collectively by the communities after 2021 for each detachment who have acted as the liaison for the Ministry of the Solicitor General, municipalities and First Nations throughout this process. Dear Jenny Leblond:

Thank you for sharing with me a copy of your letter to Prime Minister Trudeau detailing your town's support of the Council Resolution from the Municipality of Calvin regarding the National Fire Fighting Strategy.

As the natural hazard landscape continues to change, factors such as the changing climate and societal drivers are resulting in increased demands to protect the public, communities, property, critical infrastructure, and businesses in Ontario. My ministry has initiated a review to understand how best to modernize our wildland fire and other natural hazard programs that will result in improved outcomes to meet these heightened and changing demands.

Early work has been focused on understanding environmental changes and studying how other jurisdictions are adapting. To address current challenges, my ministry has made several immediate changes including:

- Investing over \$5 million to provide up to \$5000 retention bonuses to attract and retain employees in front-line fire, aviation, and critical support positions to enhance capacity for the 2024 fire season.
- Enhancing marketing strategies and platforms to recruit FireRanger and fire management program specialist positions.
- Reimbursing training costs to help remove potential cost barriers for eligible FireRanger recruits.
- Investing in Remotely Piloted Aircraft Systems (RPAS) technology and equipment to address current needs and challenges and exploring partnership opportunities to further invest in aerial fire suppression and research.
- Increasing our dedicated prevention and mitigation staff, expanding our FireSmart programs and continuing to evaluate and explore the expansion and modernization of both programs.

Our Aviation, Forest Fire and Emergency Services staff and partners are actively monitoring the current and forecasted weather to help predict wildland fire conditions. They also completed maintenance activities for all ministry owned aircrafts, reviewed equipment levels and ensured fire suppression equipment is serviceable. As this year's

fire season unfolds, we will continue to dedicate necessary resources to ensure the safety and protection of our communities.

Recently, the Honourable David Piccini, Minister of Labour, Immigration, Training and Skills Development, announced proposed legislative and regulatory amendments to support wildland firefighters and wildland fire investigators in receiving the same presumptive WSIB coverages as municipal firefighters. This would include presumptive coverage for prescribed occupational cancers, heart injuries and post-traumatic stress disorder.

Shifting to our mitigation and prevention activities, FireSmart is a national program administered by the Canadian Interagency Forest Fire Centre (CIFFC) that helps Canadians understand their wildland fire risk and decrease the likelihood of the associated negative impacts. Research indicates that the risk to communities can be substantially mitigated by conducting thorough wildland fire risk assessments and implementing FireSmart principles. These principles encompass various strategies such as public education, vegetation management, legislation, planning development considerations and emergency preparedness.

My ministry's wildland fire prevention and mitigation programs include working with communities and local partners to promote interest in and adoption of the FireSmart principles, by:

- Supporting municipalities and the public in wildland fire prevention and mitigation through community wildland fire protection planning as part of the FireSmart Program
- Focusing on reducing the threat of wildland fire through the application of several mitigation principles (e.g., vegetation management, development considerations, public education, training, emergency and wildland fire protection planning).
- Assessing, working with partners, approving and/or supporting prescribed burning initiatives to reduce hazardous wildland fire conditions as part of the prevention and mitigation programs.
- Direct engagement and active communication with industry, communities, residents, businesses and our partners about the ways they can support activities – especially during periods of high or extreme hazard – to reduce the likelihood and impact of wildland fires.

Municipal Forest Fire Management agreements provide to residents the most appropriate response to wildland fires within their community and support the important partnerships that we have across the province to support response to wildland fires.

Another helpful resource is the CIFFC <u>Strategic Plan.</u> CIFFC is a not-for-profit corporation owned and operated by the federal, provincial and territorial wildland fire management agencies. They operate seven days a week during fire season to coordinate resource sharing among member agencies and international partners. By prioritizing response coordination, resource sharing, information dissemination and international partnerships, CIFFC ensures a high level of preparedness to effectively manage wildland fires, both domestically and internationally. CIFFC is also the administrator of the national FireSmart program.

By fostering strong partnerships and leveraging available resources, we can enhance the safety and resilience of communities in the face of this natural hazard. Our mitigation team and FireSmart leads would be happy to meet with you to discuss opportunities for FireSmart training and education, as well as the Ontario FireSmart Communities Transfer Payment Program, and other opportunities related to Community Wildland Fire Protection Plans. ### BEING A BY-LAW OF THE CORPORATION OF THE TOWNSHIP OF CHISHOLM TO CLOSE, STOP UP AND DECLARE THE LANDS TO BE SURPLUS AND TO SELL PART OF THE ROAD ALLOWANCE IN BETWEEN CONCESSION 6 & 7, TOWNSHIP OF CHISHOLM, AND MORE PARTICULARLY DESCRIBED BELOW.

WHEREAS the Corporation of the Township of Chisholm has deemed it necessary and expedient to close, stop up and declare the lands to be surplus and to sell to the adjoining land owners the untravelled portion of the road allowance between Concession 6 & 7, Township of Chisholm, more particularly described below.

**AND WHEREAS** the closing, stopping up and sale of said road allowance does not deprive any person of the means of ingress or egress to and from his or her land or place of residence.

**AND WHEREAS** the lands described herein are no longer required for the purpose of a road allowance in this location.

**AND WHEREAS** a Notice of this By-law was published on two occasions in the North Bay Nugget in excess of one month before the hearing.

AND WHEREAS the lands described herein are surplus for Township purposes.

**AND WHEREAS** Council has not heard from any person who has claimed that his/her lands will be prejudicially affected by the passing of this By-law.

**NOW THEREFORE** the Council for the Corporation of the Township of Chisholm enacts as follows:

(1) All the road allowance situate, lying and being in the Township of Chisholm, in the District of Nipissing, and more particularly described as follows:

is hereby closed and stopped up.

- (2) That the unopened portion of the said road allowance will be declared surplus lands.
- (3) That the unopened portion of the said road allowance described in paragraph 1 of this Bylaw may be sold to the owner of PIN 49190-0339 (LT) PCL 6396 SEC NIP; LT 23 CON 7 CHISHOLM; DISTRICT OF NIPISSING.

A by-law to adopt the 2024 budget including estimates of all sums required for the purposes of the municipality during the year 2024 and to establish the tax rates to be levied.

WHEREAS pursuant to Section 290 of the Municipal Act, 2001, as amended, (hereinafter referred to as "The Act"), a local municipality shall in each year prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality;

AND WHEREAS Section 312(2) of The Act, provides that, for purposes of raising the general local municipality levy, a local municipality shall, each year, pass a by-law levying a separate tax rate, as specified in the by-law, on the assessment in each property class in the local municipality rateable for local municipality purposes;

AND WHEREAS Section 312(6) of The Act requires that the tax rates to be levied on the different classes of property must be in the same proportion to each other as the tax ratios established under Section 308 of The Act;

AND WHEREAS the property assessment roll on which the 2024 taxes are to be levied has been returned and revised pursuant to the provisions of the Assessment Act, R.S.O. 1990,c.A.31, as amended (hereinafter referred to as the "Assessment Act") subject to appeals at present before the Assessment Review Board, the Ontario Municipal Board and the District Court;

AND WHEREAS the "Residential/Farm Assessment", "Commercial Assessment", "Industrial Assessment", "Farmlands Assessment", "Managed Forests Assessment" and "Landfill Assessment", and the applicable subclasses pursuant to Section 7 of the Assessment Act, have been determined on the basis of the aforementioned property assessment roll;

AND WHEREAS the tax ratios and the tax ratio reductions for prescribed property subclasses on the aforementioned properties for the 2024 taxation year have been set out in By-Law 2024-13;

AND WHEREAS the tax rates on the aforementioned assessment classes and the applicable subclasses have been calculated pursuant to the provision of the Municipal Act in the manner set out herein;

AND WHEREAS the education rates for all assessment classes shall be levied in accordance with Ontario Regulation No. 132/17 which amends Ontario Regulation 400/98 of the Education Act.

NOW THEREFORE the Council of the Corporation of the Township of Chisholm ENACTS AS FOLLOWS:

- 1. THAT the Corporation adopts the sum of One Million Nine Hundred and Four Thousand Seven hundred and Ninety-Two Dollars as the gross estimate of the funds required during the year 2024 for general purposes.
- 2. THAT the tax rates for 2024 municipal purposes, as calculated and outlined in Schedule "A" attached hereto and forming part of this By-law, be hereby set.
- 3. THAT the taxes levied pursuant to the provision of this By-law shall become due and payable in two installments as follows: 50% of the final levy shall become due and payable on the 30<sup>th</sup> day of August, 2024; and the balance of the final levy shall become due and payable on the 31<sup>st</sup> day of October, 2024.
- 4. THAT the CAO Clerk-Treasurer of the Corporation of the Township of Chisholm shall mail or cause to be mailed to the address of the residence or place of business of each property or person a notice specifying the amount of taxes payable by such persons pursuant to the provisions of this By-law.

- 5. THAT the taxes payable, pursuant to this By-law, shall be paid into the office of the CAO Clerk-Treasurer of the Corporation of the Township of Chisholm on or before the respective due dates herein before set forth.
- 6. THAT the CAO Clerk-Treasurer is hereby authorized to accept part payment from time to time on account of any taxes which have become due pursuant to this By-law.
- 7. THAT in accordance with Section 345(3) of The Act, interest charges of 1.25 per cent each month of the amount of taxes due and unpaid, will be imposed for the non-payment of taxes on the first day of each calendar month thereafter in which default continues.



Re:	Request to Close and Convey an Unopened Road Allowance – Plan M-185

### BACKGROUND

The Township has received requests from 3 landowners expressing an interest in purchasing a portion of an unopened road allowance located in Plan M-185.


Plan M-185 is located in Part of Lot 5, Concession 11 with frontage on Alderdale Road. The plan was registered in 1913, presumably to support growth and development adjacent to the Canadian Northern Ontario Railway. The plan consisted of 28 lots each with dimensions of 66' x 132' (1 chain x 2 chains) as well as a perimeter 66' road allowance and one internal 66' road allowance, which bisected the plan. An excerpt of the original subdivision plan is provided in Figure 1.

### Figure 1 – Plan M-185



The subdivision plan was not developed in the manner that was originally intended and the perimeter and internal roads were not constructed and remain as unopened road allowances. Presently, the 28 original lots are understood to still exist as separate conveyable lots, however the lots are currently held by 7 owners in the manner illustrated in Figure 2.

### Figure 2 – Current Ownership of Lots within Plan M-185



The request to acquire the unopened road allowance was initiated by the owner of 1483 Alderdale Road subsequent to pre-consultations with the Township which focused on the potential to consolidate the current holding into more than one viable building lots.




Figure 3 – Location of Unopened Road Allowance and Parties Requesting Acquisition

As a result of this request, staff circulated a notice of the proposed request to close and convey the unopened road. In response to this circulation two other abutting owners (1497 Alderdale Road and 1507 Alderdale Road) also submitted requests to acquire portions of the unopened road allowance. A plan illustrating the unopened road allowance and the owners seeking to acquire portions of it is provided in Figure 3.

The rationale for each of the landowners who have submitted the request is:

- **1483 Alderdale Road** abuts the unopened road allowance and the additional lands would allow the sub-consolidation of lands in his holding to potentially create up to 3 building lots.
- **1497 Alderdale Road** abuts the unopened road allowance and operates a commercial business and the additional road allowance would avail more land for access and parking.
- **1507 Alderdale Road** abuts the unopened road allowance and is understood to have one or more buildings that encroach on the road allowance.

### THE MUNICIPAL ACT

Section 28 of the Municipal Act provides the Township with jurisdiction over all road allowances made by the Crown surveyors and within a registered plan of subdivision.

In the administration of responsibilities vested under Section 28, many municipalities have policies in place to address requests to use or to close and convey municipal road allowances. It is understood that the Township of Chisholm does not have a standalone policy in place but does have an Official Plan policy on the subject that is provided below.

### TOWNSHIP OF CHISHOLM OFFICIAL PLAN

Section D2.3.4 of the Township's Official Plan articulates the following policy with respect to the closing and conveyance of road allowances:

Unopened road allowances will be retained by the Township and may be used to accommodate future transportation needs, if warranted.

Notwithstanding, Council may pass by-laws to close any portion of an opened or unopened road allowance in accordance with the Municipal Act, and in doing so, the Township may convey ownership of some or all of the lands.

Prior to considering the closure and conveyance of any road allowance, Council will consider the following criteria:

I) If the road allowance to be closed provides an existing or potential public access to a lake or river by leading to the water's edge, Council must be satisfied that there is an adequate alternate public access to the water body in proximity to the road allowance to be closed; and,

ii) If the road allowance is used by a formalized recreational trail organization, as indicated on the Schedules or Appendices to this Plan, it must be demonstrated that the closure will not be detrimental to the greater trail network.

Where the Township is requested to close and convey any portion of a road allowance, Council may, as a condition of such conveyance, require any of the following:

i) The exchange of other property to provide appropriate land or water access;

ii) Notification of such closure and conveyance in accordance with By-law 2003-07 passed in accordance with the Municipal Act;


- iii) The subject lands be rezoned;
- iv) The removal or structural repair of buildings or structures; or

v) The prospective owner of such lands to assume responsibility for all costs associated with the closure including the preparation of a survey and all legal documents necessary to effect the land transfer.

### ANALYSIS

In consideration of Section D2.3.4, the subject road allowance does not abut or lead to water nor is it utilized by a recreational trail association. On this basis, and on the basis that the original registered plan is comprised of conveyable lots that are sub-standard in size and an unopened road allowance that serves no practical purpose, I believe Council is able to entertain the subject requests to close and convey portions of the unopened road allowance.

To this end, Figure 4 illustrates a recommended close and conveyance scenario which would transfer lands abutting each of the landowners who have made submitted requests.



#### Figure 4 - Recommended Closure Conveyance of Unopened Road Allowance

### RECOMMENDATION

If Council is in general agreement that the subject unopened road allowance should be:

- a) stopped and closed; and,
- b) conveyed to abutting landowners in the manner illustrated in Figure 4,

The following recommendation is provided:

That Council is in agreement to stop up, close and convey a portion of the unopened road allowance located within Plan M-185 in the manner illustrated in Figure 4 of the Planning Report dated May 24, 2024 and that staff be directed to prepare and bring forward a by-law to stop up, close and convey said unopened road allowance subject to the following:

- 1. Submission of a letter of acknowledgement and cost recovery agreement by each of the registered owners of 1483 Alderdale Road, 1487 Alderdale Road and 1507 Alderdale Road that they agree with the area and extent of the conveyance, to fulfil all reasonable conditions, to pay consideration in accordance with the Township's fees By-law, and to assume all Township costs related to the closure and conveyance;
- 2. Submission of one draft reference plan illustrating the proportionate Parts to be stopped up closed and conveyed to the abutting/benefitting owners who have requested the conveyances with such survey illustrating the location of existing buildings and structures located on the road allowance where applicable;
- 3. Submission of an application for zoning by-law amendment by any benefitting owner requiring a zoning amendment to address split-zoning and/or an area of non-compliance; and,
- 4. Submission of an application for a deeming by-law to consolidate existing lots held by a benefitting owner together within any portion of the closed road allowance.

### **RE: Reaching Home Funding Allocations**

Hello Mayors and Councils of Nipissing District,

I am writing to the mayors and council of the 11 municipalities that form part of the District of Nipissing, to seek your support. The District of Nipissing Social Services Administration Board (DNSSAB) has seen reduced federal funding for the Reaching Home program for 2026-27 and 2027-28 in the amount of \$738,144 for each year. The Reaching Home program provides federal funding to urban, Indigenous, rural, and remote communities to help them address their local homelessness needs. This abrupt change will present significant financial challenges for the funded agencies providing homelessness services and supports with Reaching Home funds. Communities across Canada are advocating with the Federal Government to reconsider the funding cuts, and we are asking you to do the same. (See attached Board Report #HS-2024-003 for details on the funding cuts.)

The DNSSAB has also written letters to MPs Rota and Serré, also attached, asking them to advocate for reconsideration of the Reaching Home funding decreases.

We have provided a draft recommendation below should you wish to join this advocacy in support of our district's most vulnerable individuals. We ask that you bring this recommendation or one of your own design to your council and, if passed, to share that resolution with our local federal representatives.

### DRAFT RECOMMENDATION

**THAT** (your municipality) supports the stabilization of the Federal Government's Reaching Home funding to the District of Nipissing Social Services Administration Board as the Community Entity; and,

THAT funding be maintained, at minimum, at current levels for future fiscal years; and,

**THAT** this resolution be shared with local federal representatives.

### BACKGROUND

Reaching Home Funding began in 2019, replacing the Homelessness Partnering Strategy. North Bay/Nipissing is one of 64 Designated Communities across Canada. The funding has Directives that are tied directly to the implementation of Coordinated Access and the compilation of data using the Homeless Individuals and Families Information System (HIFIS).

The DNSSAB, as Community Entity (CE), signed an original agreement with Canada for a total of \$1,190,764 base funding over five years:

Reaching Home funding in Nipissing has been used to fund shelter supports, overflow, and, over the last two years, Warming Centre operations during the winter months. The funding has also been instrumental in the development and implementation of several local pilot projects, including the Housing Unit Stability and Recovery pilot, Suswin Outreach supports, and the Salvation Army's Emergency Rehousing Program.

Reaching Home Community and Capacity Innovation funding has been essential in the development and implementation of Coordinated Access Nipissing.

### FINANCIAL AND RISK CONSIDERATIONS

During the pandemic, incremental funding was added to the base amount and this funding had less stringent parameters for eligible expenses. In Nipissing, the incremental funding was primarily used to enhance and supplement funding for agencies continuing to offer services to households experiencing homelessness during the pandemic.

In 2022, the incremental funding was combined in an amended Agreement with the original base funding and, for 2022-23 and 2023-24, Nipissing used the enhanced base funding to fund new core services within the community, including the Warming Centre with the Gathering Place (TGP) and housing supports with the Brain Injury Association of North Bay and Area (BIANBA).

In late November of 2023, Infrastructure Canada (INFC) advised DNSSAB of the funding allocations for 2024-2028:

In 2024-25 and 2025-26, overall funding for the fiscal year decreases by \$48,650 from the 2023-24 total funding. Funding for 2026-27 and 2027-28 will fall back to pre-pandemic levels. This decrease will add significant funding pressure within the system and could result in the loss of services and capacity.



On December 22, 2023, the DNSSAB received notification from INFC that winter incremental funding of \$222,599 was designated to Nipissing for priorities specific to homelessness pressures associated with unsheltered populations over the winter months. The funding may be used for eligible expenses from November 1, 2023, and must be fully expensed by April 30, 2024. Due to the short timelines for the winter incremental funding, Community Advisory Board (CAB) concurrence was not required for allocation decisions and INFC recommended that the funding be used to top up existing projects rather than create new projects. The incremental funding brings the total allocation for 2023-24 to \$1,009,393.

### RECOMMENDATIONS

**THAT** the DNSSAB support the following recommendations from the Community Advisory Board (CAB) at the meeting held January 10, 2024:

### Incremental Winter Funding 2023-24: CAB Motion #2024-04:

- Fund temporary beds from November 2023 to April 2024 for individuals relocated as the result of an encampment intervention.
- Extend the Peer Outreach Support Team staffing and security weekday and weekend hours with True Self to April 30, 2024
- Enhance the staffing for the Warming Centre and allocate extra costs for security. With these enhancements, the expected total costs will be \$389,460.

• At the January 2024 CAB meeting, the CAB passed Motion #2024-05 recommending that all Sub-Project Agreements currently funded through the 2023-24 base Reaching Home Funding have their Funding Agreements amended to extend current funding to March 31, 2025. The funding shortfall will be taken from the Coordinated Access project funding, which will leave a balance of \$17,857.15 to be used for Coordinated Access and a Point in Time (PiT) count that is mandatory in the Fall of 2024.

- The extension for 2024-25 will allow for service and staffing stability.
- During the 2024-25 fiscal year, a thorough service evaluation and review of all currently funded sub-projects will be conducted jointly with the CAB to plan for 2025-26.

### 2024-28 Funding Decreases

• The abrupt changes announced for the Reaching Home Funding for 2026-27 and 2027-28 will present significant financial challenges for the DNSSAB and the agencies providing homelessness services and supports that are funded with Reaching Home funds. Communities across Canada are advocating with the Federal Government to reconsider the funding cuts.

### NEXT STEPS

- Upon approval, current agreements with Sub-Project Agencies will be amended to reflect the funding allocations for 2023-24 and 2024-25.
- Recommend that DNSSAB communicate via letter with the Member of Parliament for Nipissing District, Anthony Rota, and Member of Parliament for Nickel Belt, Marc Serré, to advocate for reconsideration of the Reaching Home funding decreases.
- Recommend that DNSSAB collaborate with other leadership organizations, including AMO, NOSDA, OMSSA and CAEH within existing advocacy campaigns.

Please be advised that at their last regular meeting on Tuesday, May 7, 2024, the Council of the Township of Lucan Biddulph passed the following resolution:

WHEREAS the Ontario Auditor General's annual report on public health from December 2023 indicates that Public Health Ontario is proposing the phasing-out of free provincial water testing services for private drinking water; and

WHEREAS free private drinking water testing services has played a pivotal role in safeguarding public health, particularly in rural communities such as the Township of Lucan Biddulph; and

WHEREAS the removal of free private drinking water testing could lead to a reduction in testing, potentially increasing the risk of waterborne diseases in these vulnerable populations; and

WHEREAS the tragic events in Walkerton, Ontario underscored the critical importance of safe drinking water.
